Volunteer Opportunities: Office of Military Legal Assistance



On September 13, 2016, NNWLA hosted a CLE presentation by Deputy Attorney General Nic Danna and Captain Dana Grigg discussing legal issues facing our state's military popula-

tion. Nevada's Office of Military Legal Assistance (OMLA) is the nation's first Attorney General led public-private partnership providing military communities access to pro bono civil legal services. The OMLA is addressing such a critical need that the program has garnered bipartisan support and recognition from Nevada State and Federal elected officials, as well as officials from across the country. The Department of Defense has named the OMLA as a "Best Practice Program."

While service members are granted limited legal assistance from the Judge Advocate General's Corps on civil matters, the JAG Corps cannot represent service members in court on civil issues. This critical gap in legal representation negatively impacts morale and military readiness for both the service member and their family. Legal challenges increase the risk of

financial insecurity, bankruptcy, divorce, homelessness and suicide, as mounting financial pressures increase stress and decrease overall emotional and psychological health and stability.

The goal of the OMLA is to improve the military readiness, employment, health, wellness, and education outcomes for Nevada active duty military and veterans by meeting critical unmet legal needs. The OMLA is unique not only in Nevada, but is leading the country in providing active duty service members and veterans with pro bono legal assistance in a variety of civil legal matters. The OMLA is currently assisting with military rights issues (USERRA and SCRA), wills and powers of attorney, landlord/tenant issues, creditor/debtor issues, consumer fraud, naturalization/immigration, and predatory lending. Access to these services protect the financial/economic livelihood of our active duty military and veterans who may not have the financial resources to take on certain legal matters.

Once an active duty military member or veteran becomes an OMLA client, they are referred to private pro bono attorneys, legal aid affiliate partners, such as Nevada Legal Services, and
