Fighting for a TSC Cure: A Mother's Hope

My son, William Robert Tuttle III (aka "Billy"), was born January 5, 2016, and has forever changed my life in so many amazing ways. At thirty-two weeks pregnant, I experienced every expectant mother's worst nightmare: my unborn son

was diagnosed with a relatively rare and largely unknown genetic disorder called tuberous sclerosis complex ("TSC"). TSC is a genetic disorder that causes tumors to form in many different organs, primarily the brain, eyes, heart, kidneys, skin and lungs. TSC is the leading known genetic cause of both epilepsy and autism, but its potential for multi-organ involvement makes the disease's reach and impact seemingly infinite. There is no cure.

What is so distinct about TSC is that it affects some people severely, and others so mildly that it often goes undiagnosed. Some people with TSC, are sentenced to a lifetime of seizures, intellectual disabilities and autism. Others are able to live healthy, totally independ-

ent lives. It is this not knowing when, how, and to what extent the disease will manifest that is so onerous for so many, including myself.

Nearly 1 million people worldwide are known to have TSC, with approximately 50,000 in the United States. At least two children born each day in the United States will have TSC. While many cases go undiagnosed due to the obscurity of the disease and the mild form symptoms may take in some people, TSC is as common as ALS or cystic fibrosis.

TSC is a linchpin disease. The genetic pathway involved in TSC is the same pathway affecting over a dozen major diseases and disorders, including autism, epilepsy, cancer, and obesity. Insights into TSC can provide insights into other diseases; and vice versa. Discoveries in TSC can lead to discoveries in other diseases; and vice versa. New treatments in TSC can lead to new treatments in other diseases; and vice versa.

FEDERAL CJA PANEL APPLICATIONS

The United States District Court for the District of Nevada is accepting applications for appointments of new Federal Criminal Justice Act (CJA) Panel attorneys (appointment of counsel for indigent defendants) for the Unofficial Northern Division of the District of Nevada. Attorneys interested in appointment to the CJA Panel must submit an application in PDF format to Heidi_Jordan@nvd.uscourts.gov by Monday, September 12, 2016. Attorneys applying for the Appeal Panel must also submit a writing sample. Appointments for the new Panel will be effective October 3, 2016.

Applicants must be members in good standing of the bar of the Federal Court and must have demonstrated experience in, and knowledge of, the Federal Rules of Criminal Procedure, the Federal Rules of Evidence and the Federal Sentencing Guidelines. Attorneys on the CJA Panel also must have demonstrated an interest in providing criminal defense services and a reputation for competent and vigorous representation. Members of the Panel are required to participate in six (6) hours of training in federal criminal practice, with at least three (3) of the six (6) hours on the Federal Sentencing Guidelines, per year which shall be provided through the Federal Public Defender's Office or other Court approved provider of Continuing Legal Education.
